**Suggests** boot, lme4

**Description** Provides functions to analyse overdispersed counts or proportions. These functions should be considered as complements to more sophisticated methods such as generalized estimating equations (GEE) or generalized linear mixed effect models (GLMM). aods3 is an S3 re-implementation of the deprecated S4 package aod.

## Description

The function fits a beta-binomial (BB) or a negative binomial (NB) generalized linear model from clustered data.

For the BB model, data have the form  $\{(n_1, m_1), (n_2, m_2), \dots, (n_N, m_N)\}$ , where  $n_i$  is the size of cluster  $i$ ,  $m_i$  the number of “successes”, and  $N$  the number of clusters. The response is the proportion  $y = m/n$ .

For the NB model, data can be of two types. When modeling simple counts, data have the form  $\{m_1, m_2, \dots, m_N\}$ , where  $m_i$  is the number of occurrences of the event under study. When modeling rates (e.g. hazard rates), data have the same form as for the BB model, where  $n_i$  is the denominator of the rate for cluster  $i$  (considered as an “offset”, i.e. a constant known value) and  $m_i$  the number of occurrences of the event. For both types of data, the response is the count  $y = m$ .

### Arguments

formula	<p>A formula for the mean <math>\mu</math>, defining the parameter vector <math>b</math> (see details). For the BB model, the left-hand side of the formula must be of the form <code>cbind(m, n - m) ~ ...</code> where the fitted proportion is <math>m/n</math>. For the NB model, the left-hand side of the formula must be of the form <code>m ~ ...</code> where the fitted count is <math>m</math>. To fit a rate, argument <code>offset</code> must be used in the right-hand side of the formula (see examples).</p>
data	A data frame containing the response ( $m$ and, optionnally, $n$ ) and the explanatory variable(s).
family	Define the model which is fitted: “bb” for the BB model and “nb” for the NB model.
link	For the BB model only. Define the link function $g$ for the mean $\mu$ : “cloglog”, “logit” (default) or “probit”. For the NB model, link is automatically set to “log”.
phi.formula	A right-hand side formula to model optional heterogeneity for the over-dispersion parameter $\Phi$ (see details). Only one single factor is allowed. Default to <code>formula(~ 1)</code> (i.e. no heterogeneity).
phi.scale	Scale on which $\Phi$ is estimated (see details): “identity” (default), “log” or “inverse”.
phi.start	Optional starting values for $\Phi$ . Default to 0.1.
fixpar	<p>An optional list of 2 vectors of same length (<math>\geq 1</math>) to set some parameters as constant in the model.</p> <p>The first vector indicates which parameters are set as constant (i.e., not optimized) in the global parameter vector <math>(b, \Phi)</math>.</p> <p>The second vector indicates the corresponding values. For instance, <code>fixpar = list(c(4, 5), c(0, 0.1))</code> means that the 4th and 5th components of vector <math>(b, \Phi)</math> are set to 0 and 0.1. Argument <code>fixpar</code> can be usefull, for instance, to calculate profiled log-likelihoods.</p>

hessian	A logical (default to TRUE). If FALSE, the hessian and the variances-covariances matrices of the parameters are not calculated.
method	Define the method used for the optimization (see <a href="#">optim</a> ).
control	A list to control the optimization parameters. See <a href="#">optim</a> . By default, the maximum number of iterations is set to 3000, and trace is set to 0 to avoid spurious warnings.
object	An object of class aodml
x	An object of class aodml
digits	Number of digits to print in <code>print.summary.aodml</code> and <code>print.anova.aodml</code> . Default to <code>max(3, getOption("digits") - 3)</code>
...	Further arguments passed to <a href="#">optim</a> (e.g. argument <code>method</code> if using function <code>aodml</code> ), or further objects of class <code>aodml</code> (function <code>anova.aodml</code> ), or further arguments passed to <code>print.aodml</code> and <code>print.anova.aodml</code> .
what	For function <code>fitted</code> , a character string indicating the type of fitted values to be returned: legal values are "mu" for the fitted response; "nu" for the fitted linear predictor without offset (link scale); "eta" for the fitted linear predictor with offset (link scale); "phi" for the fitted overdispersion coefficient.
type	For function <code>residuals</code> , a character string indicating the type of residuals to be computed; legal values are "deviance" for the deviance's residuals, "pearson" for the Pearson's residuals, and "response" for the response. For function <code>predict</code> , a character string indicating the type of prediction to be computed; legal values are "link" and "response".
k	Numeric scalar for the penalty parameter used to compute the information criterion. The default value ( $k = 2$ ) is the regular AIC $= -2 * \log\text{Lik} + 2 * p$ , where $p$ is the number of model coefficients. NB: for AICc, $k$ is set to 2, and $\text{AICc} = \text{AIC} + 2 * p * (p + 1) / (n - p - 1)$ , with $n$ the number of observations.
se.fit	Logical scalar indicating whether standard errors should be computed for the predicted values. Default to FALSE.
newdata	A <code>data.frame</code> containing the explanatory variables - and possibly the offset - for the values of which predictions are to be made.

## Details

### Beta-binomial model (BB)

For a given cluster  $(n, m)$ , the model is

$$m|\lambda, n \text{ Binomial}(n, \lambda)$$

where  $\lambda$  follows a Beta distribution  $\text{Beta}(a_1, a_2)$ . Noting  $B$  the beta function, the marginal (beta-binomial) distribution of  $m$  is

$$P(m|n) = C(n, m) * B(a_1 + m, a_2 + n - m) / B(a_1, a_2)$$

Using the re-parameterization  $\mu = a_1/(a_1 + a_2)$  and  $\Phi = 1/(a_1 + a_2 + 1)$ , the marginal mean and variance are

$$E[m] = n * \mu$$

$$Var[m] = n * \mu * (1 - \mu) * (1 + (n - 1) * \Phi)$$

The response in aodml is  $y = m/n$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = g^{-1}(X * b) = g^{-1}(\nu)$ , where  $g$  is the link function,  $X$  is a design-matrix,  $b$  a vector of fixed effects and  $\nu = X * b$  is the corresponding linear predictor. The variance is  $Var[y] = (1/n) * \mu * (1 - \mu) * (1 + (n - 1) * \Phi)$ .

### Negative binomial model (NB)

— *Simple counts (model with no offset)*

For a given cluster ( $m$ ), the model is

$$y|\lambda \text{Poisson}(\lambda)$$

where  $\lambda$  follows a Gamma distribution of mean  $\mu$  and shape  $k$  ( $Var[\lambda] = \mu^2/k$ ). Noting  $G$  the gamma function, the marginal (negative binomial) distribution of  $m$  is

$$P(m) = G(m + k)/(m! * G(k)) * (k/(k + \mu))^k * (\mu/(k + \mu))^m$$

Using the re-parameterization  $\Phi = 1/k$ , the marginal mean and variance are

$$E[m] = \mu$$

$$Var[m] = \mu + \Phi * \mu^2$$

The response in aodml is  $y = m$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = exp(X * b) = exp(\nu)$ . The variance is  $Var[y] = \mu + \Phi * \mu^2$ .

— *Rates (model with offset)*

For a given cluster ( $n, m$ ), the model is

$$m|\lambda, n \text{Poisson}(\lambda)$$

The marginal (negative binomial) distribution  $P(m|n)$  is the same as for the case with no offset ( $= P(m)$ ). The response in aodml is  $y = m$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = exp(X * b + log(n)) = exp(\nu + log(n)) = exp(\eta)$ , where  $log(n)$  is the offset. The variance is  $Var[y] = \mu + \Phi * \mu^2$ .

### Other details

Argument `phi.scale` of function `aodml` enables to estimate the over-dispersion parameter under different scales.

If `phi.scale = "identity"` (Default), the function estimates  $\Phi$ .

If `phi.scale = "log"`, the function estimates  $\log(\Phi)$ .

If `phi.scale = "inverse"`, the function estimates  $1/\Phi$ .

The full parameter vector returned by `aodml`, say `param`, is equal to  $(b, \Phi)$ . This vector is estimated by maximizing the log-likelihood of the marginal model using function `optim`. The estimated variances-covariances matrix of `param` is calculated by the inverse of the observed hessian matrix returned by `optim`, and is referred to as `varparam`.

### Value

An object of class `aodml`, printed and summarized by various functions. Function `deviance.aodml` returns the value  $-2 * (\log L - \log L_{\max})$ . The “deviance” used in function `AIC.aodml` to calculate AIC and AICc is  $-2 * \log L$ .

## Description

From clustered data, the function fits generalized linear models containing an over-dispersion parameter  $\Phi$  using quasi-likelihood estimating equations for the mean  $\mu$  and a moment estimator for  $\Phi$ .

For binomial-type models, data have the form  $\{(n_1, m_1), (n_2, m_2), \dots, (n_N, m_N)\}$ , where  $n_i$  is the size of cluster  $i$ ,  $m_i$  the number of “successes”, and  $N$  the number of clusters. The response is the proportion  $y = m/n$ .

For Poisson-type models, data can be of two forms. When modeling “simple counts”, data have the form  $\{m_1, m_2, \dots, m_N\}$ , where  $m_i$  is the number of occurrences of the event under study. When modeling rates (e.g. hazard rates), data have the same form as for the BB model, where  $n_i$  is the denominator of the rate for cluster  $i$  (considered as an “offset”, i.e. a constant known value) and  $m_i$  the number of occurrences of the event. For both forms of data, the response is the count  $y = m$ .

## Arguments

formula	A formula for the mean $\mu$ , defining the parameter vector $b$ (see details). For binomial-type models, the left-hand side of the formula must be of the form <code>cbind(m, n - m) ~ ...</code> where the fitted proportion is $m/n$ . For Poisson-type models, the left-hand side of the formula must be of the form <code>m ~ ...</code> where the fitted count is $m$ . To fit a rate, argument <code>offset</code> must be used in the right-hand side of the formula (see examples).
data	A data frame containing the response ( $m$ and, optionnally, $n$ ) and the explanatory variable(s).
family	Define the model which is fitted: “qbin” for binomial-type models and “qpois” for Poisson-type models.
link	For binomial-type models only. Define the link function $g$ for the mean $\mu$ : “cloglog”, “logit” (default) or “probit”. For Poisson-type models, <code>link</code> is automatically set to “log”.
method	For function <code>aodql</code> , define the statistics used for the moment estimation of $\phi$ ; legal values are “chisq” (default) for the chi-squared statistics or “dev” for the deviance statistics.
phi	An optional value defining the over-dispersion parameter $\Phi$ if it is set as constant. Default to NULL (in that case, $\Phi$ is estimated).
tol	A positive scalar (default to 0.001). The algorithm stops at iteration $r + 1$ when the condition $\chi^2[r + 1] - \chi^2[r] \leq tol$ is met by the $\chi^2$ statistics .
...	Further arguments to passed to the appropriate functions.
object	An object of class “aodql”.
x	An object of class “aodql”.

## Details

### Binomial-type models

For a given cluster  $(n, m)$ , the model is

$$m|\lambda, n \sim \text{Binomial}(n, \lambda)$$

where  $\lambda$  follows a random variable of mean  $E[\lambda] = \mu$  and variance  $Var[\lambda] = \Phi * \mu * (1 - \mu)$ . The marginal mean and variance of  $m$  are

$$E[m] = n * \mu$$

$$Var[m] = n * \mu * (1 - \mu) * (1 + (n - 1) * \Phi)$$

The response in aodq1 is  $y = m/n$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = g^{-1}(X * b) = g^{-1}(\nu)$ , where  $g$  is the link function,  $X$  is a design-matrix,  $b$  a vector of fixed effects and  $\nu = X * b$  is the corresponding linear predictor. ### Poisson-type models

— *Simple counts (model with no offset)*

where  $\lambda$  follows a random distribution of mean  $\mu$  and variance  $\Phi * \mu^2$ . The mean and variance of the marginal distribution of  $m$  are

$$E[m] = \mu$$

$$Var[m] = \mu + \Phi * \mu^2$$

The response in aodq1 is  $y = m$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = exp(X * b) = exp(\nu)$ . The variance is  $Var[y] = \mu + \Phi * \mu^2$ .

— *Rates (model with offset)*

For a given cluster ( $n, m$ ), the model is

$$m|\lambda, n \sim Poisson(\lambda)$$

where  $\lambda$  follows the same random distribution as for the case with no offset. The marginal mean and variance are

$$E[m|n] = \mu$$

$$Var[m|n] = \mu + \Phi * \mu^2$$

The response in aodq1 is  $y = m$ . The mean is  $E[y] = \mu$ , defined such as  $\mu = exp(X * b + log(n)) = exp(\nu + log(n)) = exp(\eta)$ , where  $log(n)$  is the offset. The variance is  $Var[y] = \mu + \Phi * \mu^2$ .

### Other details

Vector  $b$  and parameter  $\Phi$  are estimated iteratively, using procedures referred to as "Model I" in Williams (1982) for binomial-type models, and "Procedure II" in Breslow (1984) for Poisson-type models.

Iterations are as follows. Quasi-likelihood estimating equations (McCullagh & Nelder, 1989) are used to estimate  $b$  (using function `glm` and its `weights` argument),  $\Phi$  being set to a constant value. Then,  $\Phi$  is calculated by the moment estimator, obtained by equalizing the goodness-of-fit statistic (chi-squared  $\chi^2$  or deviance  $D$ ) of the model to its degrees of freedom.

Parameter  $\Phi$  can be set as constant, using argument `phi`. In that case, only  $b$  is estimated.

The function tests the homogeneity of probabilities between  $J$  groups ( $H_0: \mu_1 = \mu_2 = \dots = \mu_J$ ) from clustered binomial data  $\{(n_1, m_1), (n_2, m_2), \dots, (n_N, m_N)\}$ , where  $n_i$  is the size of cluster  $i$ ,  $m_i$  the number of “successes” (proportions are  $y = m/n$ ), and  $N$  the number of clusters. The function uses adjusted chi-squared statistics, with either the correction proposed by Donner (1989) or the correction proposed by Rao and Scott (1993).

## Details

### Donner's test

The chi-squared statistic is adjusted with the correction factor  $C_j$  computed in each group  $j$ . The test statistic is given by:

$$X^2 = \sum_j ((m_j - n_j * \mu)^2 / (C_j * n_j * \mu * (1 - \mu)))$$

where  $\mu = \sum_j (m_j) / \sum_j (n_j)$  and  $C_j = 1 + (n_{A,j} - 1) * \rho$ .  $n_{A,j}$  is a scalar depending on the cluster sizes, and  $\rho$  is the ANOVA estimate of the intra-cluster correlation assumed common across groups (see Donner, 1989 or Donner et al., 1994). The statistic is compared to a chi-squared distribution with  $J - 1$  degrees of freedom. Fixed correction factors  $C_j$  can be specified with the argument C.

### Rao and Scott's test

The method uses design effects and "effective" sample sizes. The design effect  $C_j$  in each group  $j$  is estimated by  $C_j = v_{ratio,j} / v_{bin,j}$ , where  $v_{ratio,j}$  is the variance of the ratio estimate of the probability in group  $i$  (Cochran, 1999, p. 32 and p. 66) and  $v_{bin,j}$  is the standard binomial variance. The  $C_j$  are used to compute the effective sample sizes  $n_{adj,j} = n_j / C_j$ , the effective numbers of successes  $m_{adj,j} = m_j / C_j$  in each group  $j$ , and the overall effective proportion  $mu_{adj} = \sum_j m_{adj,j} / \sum_j C_j$ . The test statistic is obtained by substituting these quantities in the usual chi-squared statistic, yielding:

$$X^2 = \sum_j ((m_{adj,j} - n_{adj,j} * mu_{adj})^2 / (n_{adj,j} * mu_{adj} * (1 - mu_{adj})))$$

which is compared to a chi-squared distribution with  $J - 1$  degrees of freedom.

A pooled design effect over the  $J$  groups is estimated if argument `pooled = TRUE` (see Rao and Scott, 1993, Eq. 6). Fixed design effects  $C_j$  can be specified with the argument C.

$$X^2 = \sum_i ((y_i - \mu)^2 / Var[y_i])$$

Assuming that the data length is  $N$  and the number of the parameters in the model is  $p$ ,  $D$  and  $X^2$  are compared to a chi-squared distribution with  $N - p$  degrees of freedom.

$\{(n_1, m_1), (n_2, m_2), \dots, (n_N, m_N)\}$ ,

where  $n_i$  is the size of cluster  $i$ ,  $m_i$  the number of “successes” (proportions are  $y = m/n$ ), and  $N$  the number of clusters. The function uses a one-way random effect model. Three estimates, corresponding to methods referred to as “A”, “B” and “C” in Goldstein et al. (2002), can be returned.

**Details**

Before computations, the clustered data are split to binary “0/1” observations  $y_{ij}$  (observation  $j$  in cluster  $i$ ). The methods of calculation are described in Goldstein et al. (2002).

Methods "A" and "B" use the 1-way logistic binomial-Gaussian model

$$y_{ij} | \mu_{ij} \sim \text{Bernoulli}(\mu_{ij})$$

$$\text{logit}(\mu_{ij}) = b_0 + u_i,$$

where  $b_0$  is a constant and  $u_i$  a cluster random effect with  $u_i \sim N(0, s_u^2)$ . The ML estimate of the variance component  $s_u^2$  is calculated with the function `glmer` of package **lme4**. The intra-class correlation  $\rho = \text{Corr}[y_{ij}, y_{ik}]$  is then calculated from a first-order model linearization around  $E[u_i] = 0$  in method “A”, and with Monte Carlo simulations in method “B”.

Method "C" provides the common ANOVA (moment) estimate of  $\rho$ . For details, see for instance Donner (1986), Searle et al. (1992) or Ukoumunne (2002).

For each litter the number  $n$  of pups alive at 4 days and the number  $x$  of pups that survived the 21 day lactation period were recorded.” (Williams, 1975, p. 951).

**Usage**

**Format**

A data frame with 32 observations on the following 3 variables.

**group** A factor with levels CTRL and TREAT

**n** A numeric vector: the number of pups alive at 4 days.

**m** A numeric vector: the number of pups that survived the 21 day lactation.

“Data for our third example were compiled by Margolin et al. (1981) from an Ames *Salmonella* reverse mutagenicity assay. Table 1 shows the number of revertant colonies observed on each of 3 replicate plates tested at each of 6 dose levels of quinoline.” (Breslow, 1984, Table 1).

### Format

A data frame with 18 observations on the following 2 variables.

**dose** a numeric vector: the dose level of quinoline (microgram per plate).

**m** a numeric vector: the number of revertant colonies of TA98 *Salmonella*.

### Description

The function splits grouped binomial data and optional covariates to individual binary data. Two types of grouped data are managed by splitbin:

- Grouped data with weights;
- Grouped data of form cbind(success, failure).

When weights, successes or failures involve non-integer numbers, these numbers are rounded (using round()) before splitting.

### Usage

```
splitbin(formula, data, id = "idbin")
```

**Arguments**

formula	A formula. The left-hand side describes the grouped data. The right-hand side describes the covariates. See examples for syntax.
data	A data frame where all the variables described in formula are found.
id	An optional character string naming the identifier (= grouping factor). Default to "idbin".

**Value**

A data frame built according to the formula and function used in the call.

varbin

*Estimate of a Probability from Clustered Binomial Data*


---

**Description**

The function estimates a probability and its variance from clustered binomial data

$$\{(n_1, m_1), (n_2, m_2), \dots, (n_N, m_N)\},$$

where  $n_i$  is the size of cluster  $i$ ,  $m_i$  the number of "successes" (proportions are  $y = m/n$ ), and  $N$  the number of clusters. Confidence intervals are calculated using a normal approximation, which might be inappropriate when the probability is close to 0 or 1.

**Usage**

```
varbin(n, m, alpha = 0.05, R = 5000)

## S3 method for class 'varbin'
print(x, ...)
```

**Arguments**

n	A vector of the sizes of the clusters.
m	A vector of the numbers of successes (proportions are $y = m/n$ ).
alpha	The significance level for the confidence intervals. Default to 0.05, providing 95% CI's.
R	The number of bootstrap replicates to compute bootstrap mean and variance. Default to 5000.
x	An object of class "varbin".
...	Further arguments to be passed to "print".

**Details**

Five methods are used for the estimations. Let us consider  $N$  clusters of sizes  $n_1, \dots, n_N$  with observed count responses  $m_1, \dots, m_N$ . We note  $y_i = m_i/n_i$  ( $i = 1, \dots, N$ ) the observed proportions. The underlying assumption is that the probability, say  $\mu$ , is homogeneous across the clusters.

**Binomial method:** the probability estimate and its variance are calculated by

$\mu = (\text{sum}_i(m_i))/(\text{sum}_i(n_i))$  (ratio estimate) and  
 $\mu * (1 - \mu)/(\text{sum}_i(n_i) - 1)$ , respectively.

**Ratio method:** the probability  $\mu$  is estimated as for the binomial method (ratio estimate). The one-stage cluster sampling formula is used to calculate the variance of  $\mu$  (see Cochran, 1999, p. 32 and p. 66).

**Arithmetic method:** the probability is estimated by  $\mu = \text{sum}_i(y_i)/N$ . The variance of  $\mu$  is estimated by  $\text{sum}_i(y_i - \mu)^2/(N * (N - 1))$ .

**Jackknife method:** the probability is estimated by  $\mu$  defined by the arithmetic mean of the pseudovalues  $y_{v,i}$ . The variance is estimated by  $\text{sum}_i(y_{v,i} - \mu)^2/(N * (N - 1))$  (Gladen, 1977, Paul, 1982).

**Bootstrap method:**  $R$  samples of clusters of size  $N$  are drawn with equal probability from the initial sample  $(y_1, \dots, y_N)$  (Efron and Tibshirani, 1993). The bootstrap estimate  $\mu$  and its estimated variance are the arithmetic mean and the empirical variance (computed with denominator  $R - 1$ ) of the  $R$  binomial ratio estimates, respectively.

**Value**

An object of class varbin, printed with `print.varbin`.

*Wald Test for Model Coefficients*

---

## Description

The function returns a Wald chi-squared test or a  $F$  test for a vector of model coefficients (possibly of length one), given its variance-covariance matrix.

## Usage

```
wald.test(b, varb, Terms = NULL, L = NULL, H0 = NULL, df = NULL, verbose = FALSE, ...)

## S3 method for class 'wald.test'
print(x, ..., digits = max(3, getOption("digits") - 3))
```

## Arguments

- |       |   |
|-------|---|
| b     | A vector of coefficients with their var-cov matrix varb. Coefficients b and var-cov matrix are usually extracted using appropriate coef and vcov functions.   |
| varb  | A var-cov matrix of coefficients b (see above).   |
| Terms | An optional integer vector specifying which coefficients should be <i>jointly</i> tested, using a Wald chi-squared test or a $F$ test. The elements of varb correspond to the columns or rows of the var-cov matrix given in varb. Default is NULL. |
| L     | An optional matrix conformable to b, such as its product with b i.e., $L \%*\% b$ gives the linear combinations of the coefficients to be tested. Default is NULL.  |

<code>H0</code>	A numeric vector giving the null hypothesis $H_0$ for the test. It must be as long as <code>Terms</code> or must have the same number of columns as <code>L</code> . Default to 0 for all the coefficients to be tested.
<code>df</code>	A numeric vector giving the degrees of freedom to be used in an $F$ test, i.e. the degrees of freedom of the residuals of the model from which <code>b</code> and <code>varb</code> were fitted. Default to <code>NULL</code> , for no $F$ test. See the section <b>Details</b> for more information.
<code>verbose</code>	A logical scalar controlling the amount of output information. The default is <code>FALSE</code> , providing minimum output.
<code>x</code>	An object of class "wald.test"
<code>digits</code>	A numeric scalar indicating the number of digits to be kept after the decimal place.
<code>...</code>	Additional arguments to <code>print</code> .

### Details

The assumption is that the coefficients follow asymptotically a multivariate normal distribution with mean equal to the model coefficients `b` and variance equal to their var-cov matrix `varb`.

One (and only one) of `Terms` or `L` must be given. When `L` is given, it must have the same number of columns as the length of `b`, and the same number of rows as the number of linear combinations of coefficients.

When `df` is given, the chi-squared Wald statistic is divided by `m`, the number of linear combinations of coefficients to be tested (i.e., `length(Terms)` or `nrow(L)`). Under the null hypothesis  $H_0$ , this new statistic follows an  $F(m, df)$  distribution.

### Value

An object of class `wald.test`, printed with `print.wald.test`.
